

REFLECTIX TENDER FINISHING AID WITH REACTIVE COLLOIDAL SILICA

ReflectiXTENDER® Finishing Aid is a non-film forming topical additive that is applied directly onto newly placed concrete before and during the trowel machine process. XTENDER® has been formulated with colloidal silica technologies which react with lime in the cement paste forming a silica compound that retains nearly all the surface moisture; an even-hydration barrier that does not allow excessive moisture to escape which ultimately eliminates volume loss that causes shrinkage, craze cracking, spalling, and curling. This allows flatwork crews to gain unprecedented control by significantly extending the workable time in adverse weather conditions therefore reducing the risk of a slab prematurely setting.

In addition to creating additional CSH/cementitious material sub-surface, XTENDER® increases the cream/paste in the 'cap' region which immediately improves its workability making it easier for the finishing crews to deliver a smooth, flat surface resulting in exceedingly high, stable FF/FL numbers, higher compressive strength, and surface abrasion. Using ReflectiXTENDER® significantly reduces blade friction &/or drag, operator fatigue, and trowel wear.

ReflectiXTENDER® does not alter the water-to-cement ratio, therefore eliminating the need to add water or accelerated chemicals which can be detrimental to the overall surface performance. It also aids in the application of shake-on hardeners in low bleed-water environments.

STORAGE & HANDLING

Do not allow product to freeze. Store in a well ventilated, cool, dry location and maintain temperatures between 40° -100°F (4°-38°C). Do not alter or mix with other chemicals. Maintain unused product in the original container. Any container that cannot be saved for recovery or recycling should be triple rinsed and disposed of in accordance with local, state, and federal regulations.

ReflectiXTENDER® is designed to be used directly after the screed before bull float or prior to panning.

APPLICATION DIRECTIONS

For each application, apply a fine spray uniformly onto the surface using a High-Volume Low-Pressure manual or commercial grade sprayer and power trowel equipment. Coverage rates of 1,200 SF²/g (29.4 m²/L) in 3 equal applications. Application rates of less than 400 SF²/g (9.8 m²/L) will delay the set.

1st Application: Apply ReflectiXTENDER® directly after the screed placement, before breaking open the floor with floats or pans.* Completely work product into the surface using a power trowel equipped with float pans.

2nd Application: Apply uniformly, work product in. **3rd Application:** Apply uniformly, work product in.

Finish by burning/burnishing the floor to the desired level using lowest pitch possible. » Having blades pitched too high will cause cutting/damage the surface. Prepare for the next application with **ReflectiFIER® Concrete Placement & Finishing Densifier** and refer to its application directions.

*Follow Industry best practices & procedures to begin the floating or panning process as you would on a standard pour.

» Float shoes may be worn when using walk-behind trowels, not recommended to use on ride-on trowels to prevent potential injuries.

CLEAN UP // DISPOSAL

Use soap and water. Any product that cannot be saved or recycled should be triple rinsed and disposed of according to local, state, and federal regulations.

MAINTENANCE

Routine cleaning with ReflectiCLEAN® Concrete Cleaner is recommended using a micro-fiber mop or auto scrubber equipped with soft pads. Do NOT use string mops. DO NOT USE cleaners that have butyl compounds or citrus, these acidic cleaners will damage the floor.
