This reactivity with the concrete mix-design also increases the surface density and abrasion resistance. The grout fill being produced is an exact match in color to the substrate therefore creating a finished floor that will look like it never had any imperfections.

200 to 600 SF / Gal. (10 - 15 m²/L)

STORAGE & HANDLING

PRE-SURFACE TESTING

To assure the desired performance and appearance specifications are met, it is highly recommended to perform a mock-up on each slab being treated using the exact same floor products, coverage rates, tooling, process, methods, technique, equipment and Certified Installer.

SURFACE PREP

Auto Scrub the surface with ReflectiCLEAN Concrete Cleaner to remove any dirt particles or any slurry created from previous grinding process.

APPLICATION DIRECTIONS

Application temperature range should be between 40° - 90° F (5° – 32° C) for optimal performance.

Coverage rates will vary based on the substrates porosity due to how 'open' the surface has been left at from prior grinding steps and if grinding wet or dry.

Application of ReflectiFILL[®] will typically be used after grinding with the higher grit REFYNE[®] Metal Diamonds &/or the REFYNE[®] 50 grit or 100 grit Hybrid Diamonds.

Clean the floor with ReflectiCLEAN Concrete Cleaner prior to ReflectiFILL® application.

Using a low-pressure sprayer, spray evenly at the rate of 200 - 600 SF² / gal directly in the grinder's path up to 10 feet or less, not getting to far ahead to ensure the product doesn't dry too quickly. Saturate the floor, but do not create puddles. Work product in with a soft bristled broom to ensure it is getting into all the cracks and voids.

NOTE: Floor having higher moisture will ensure the product will not dry out too quickly and help create the slurry consistency needed. *Dry Grinding: To create moisture in floor, section out areas, add water from hose or an auto scrubber and allow to dwell at least 20 minutes. Auto Scrub any standing water before applying ReflectiFILL®.

MAINTENANCE

Routine cleaning with ReflectiCLEAN[®] Concrete Cleaner is recommended using a micro-fiber mop or auto scrubber equipped with soft pads. Do NOT use string mops. DO NOT USE cleaners that have butyl compounds or citrus, these acidic cleaners will damage the floor.

CLEAN UP // DISPOSAL

Use soap and water. Any product that cannot be saved or recycled should be triple rinsed and disposed of according to local, state, and federal regulations.
