DUST PROOF CONCRETE DENSIFIER

ReflectiDP® Dust Proof Densifier is a penetrating, non-film forming densifier that provides a dust-proof surface. It's penetrating components chemically react with the concrete matrix creating additional calcium silicate hydrate (CSH) structures within the pores, while also filling near surface voids. These new cementitious materials are permanently bonded together resulting in the slab having increased density and abrasion resistance.

ReflectiDP® Dust Proof Densifier provides some hydrophobic properties which will improve water and stain resistance.* ReflectiDP® may be used on new or existing concrete to strengthen floors that are old, weak, soft, poorly finished, or have high porosity.

*If a higher hydrophobic protective barrier is needed for repelling water, oil, and other common contaminants, it is recommend to use ReflectiFINISH® Concrete Sealer & Guard after ReflectiDP® application.

APPLICATION RATES

400 to 800 SF² / Gal. (9.8 to 19.6 m²/L)

Coverage rates and drying times will vary due to the wide variety of differences in concrete's quality, porosity, temperature, and relative humidity.

STORAGE & HANDLING

Do not allow product to freeze. Store in a well ventilated, cool, dry location and maintain temperatures between 40° - 100°F (4°-38°C). Do not alter or mix with other chemicals. Maintain unused product in the original container. Any container that cannot be saved for recovery or recycling should be triple rinsed and disposed of in accordance with local, state, and federal regulations.

PRE-SURFACE TESTING

To assure the desired performance and appearance specifications are met, it is highly recommended to perform a mock-up on each slab being treated using the exact same floor products, coverage rates, tooling, process, methods, technique, equipment and Certified Installer.

SURFACE PREP

Surface must be clean and free of any material that would inhibit the penetration of ReflectiDP®. This includes dust, dirt, contaminants, any surface coatings, curing or sealing compounds.

APPLICATION DIRECTIONS

Apply ReflectiDP® Densifier using a <u>low-pressure</u> sprayer only and apply sufficient material to saturate the surface.

Use a soft bristled broom to spread product evenly on the entire surface. Apply enough ReflectiDP® to keep the surface wet for a minimum of 30 minutes.

In order to have even absorption and drying rates, additional product may need to be applied if any areas are noticed drying out before the 30 minute penetration time. If there are areas noticed where ReflectiDP® is pooling in lower spots towards the end the 30 minute penetration time, spread product out with a soft bristled broom or squeegee to maintain even saturation/absorption rates or remove it.

Allow ReflectiDP® to completely dry into the surface and finish to floor specifications.

*Application rates &/or drying times will vary depending on porosity, temperature &/or relative humidity.

CLEAN UP // DISPOSAL

Use soap and water. Any product that cannot be saved or recycled should be triple rinsed and disposed of according to local, state, and federal regulations.

MAINTENANCE

Routine cleaning with ReflectiCLEAN® Concrete Cleaner is recommended using a micro-fiber mop or auto scrubber equipped with soft pads. Do NOT use string mops. DO NOT USE cleaners that have butyl compounds or citrus, these acidic cleaners will damage the floor.

SAFETY & FIRST AID

If the concrete surface does not remain hardened and dust-proof as specified, Concrete Polishing & Prep Solutions, Inc. will provide the correct amount of material needed to remedy the affected area on the specified project. The manufacturer's obligation shall be limited to supplying only the chemical materials needed.
